CORPORATE PROFILE

Structured as a Holding Company in 2006, the Company has two wholly-owned subsidiaries - Celesc Geração S.A. and Celesc Distribuição S.A. In addition, it holds the controlling interest of the Gas Company of Santa Catarina (SCGÁS) and is a partner of the companied named Dona Francisca Energética S.A. (DFESA), Companhia Catarinense de Transmissão de Energia S.A. (ECTE), Companhia Catarinense de Água e Saneamento (CASAN), and of the Usina Hidrelétrica Cubatão S.A.. Its controlling shareholder is the State of Santa Catarina, holder of 50.2% of the Company's ordinary shares, corresponding to 20.2% of the Total Capital.



HIGHLIGHTS OF THE PERIOD

- Total Billed Energy, in the concession area of CELESC D, totaled 5,889 GWh, highlighting the Captive Market, which expanded by 1.0% in the quarter, totaling 3,691 GWh;
- Quality of service indicators: DEC totaled 7.43 hours (19% reduction) and FEC was 5.13 times (16.7% decrease) in the first nine months of 2018;
- Consolidated Net Operating Revenue (excluding Revenue from Construction) totaled R\$ 2.1 billion in the quarter, an increase of 16.1% and R\$ 5.6 billion in the year (up 10.8%);
- Non-manageable expenses (energy costs) increased by 23.3% (+ R\$ 331.4 million) in 3Q18 and 23% (+ R\$ 840 million) in 9M18;
- Manageable expenses (PMSO) increased by 7.5% in the quarter, with a 3.1% reduction in the year, the effect of the company's actions to reduce expenses;
- Consolidated Net Income of R\$ 42.1 million (R\$ 182.3 million in the year), with the subsidiary Celesc D totaling R\$ 28.9 million in the quarter (R\$ 148.5 million in the year) and the subsidiary Celesc Geração R\$ 14, 8 million in the quarter (R\$ 43.0 million year);
- Consolidated EBITDA of R\$ 118.6 million in the quarter (R\$ 510.4 million in the year), with the subsidiary Celesc D totaling R\$ 94.9 million in the quarter (R\$ 445.7 million in the year) and Celesc Geração R\$ 25, 1 million quarter (R\$ 73.3 million in the year);
- The Celesc Group ended the period with a Net Consolidated Debt of R\$ 559.0 million, equivalent to 0.9x Adjusted EBITDA 12M;
- Investments in distribution and generation of electric energy totaled R\$ 121.7 million in the quarter, of which R\$ 118.7 million was in distribution and R\$ 3.0 million in generation; and
- The preferred shares of Celesc (CLSC4) changed positively 9.79% in the quarter and in the twelve-month period accumulated appreciation of 48.15%.









Wholly-owned Subsidiaries

Celesc Distribuição S.A.

The company carries energy to more than 2.9 million consumer units located in 258 municipalities in Santa Catarina (92% of the state's territory) and in Rio Negro, in Paraná. On a monthly basis, the company distributes more than 1.8 million MWh and its annual gross sales reached the amount of R\$ 11.3 billion in 2017.

Celesc Geração S.A.

Celesc Geração is the subsidiary of the Celesc Group that operates in the electric power generation segment through the operation, maintenance and expansion of its own generation park and participation in power generation projects in partnerships with private investors. Celesc Geração's total generation capacity in operation in the period was 115.02 MW, with 106.97 MW referring to its own park and 8.05 MW referring to the generator set established with partners - already proportional to the Celesc Geração shareholding in these enterprises.

Companhia de Gás de Santa Catarina - SCGÁS

SCGÁS is the second largest gas distributor in the number of municipalities served in Brazil. Santa Catarina is the third state with the largest natural gas distribution network (1,144.04 kilometers) and the third with the largest number of industries served with natural gas, as well as having the third largest network of vehicular gas stations (NGV) parents. With 100% of the concession to operate natural gas distribution services in the territory of Santa Catarina, the company markets and distributes approximately 1.9 million cubic meters of natural gas daily to approximately 13.0 thousand customers.
