**ECORODOVIAS INFRAESTRUTURA E LOGÍSTICA S.A.** (“Company” or “Ecorodovias”), in compliance with Article 12 of the Securities and Exchange Commission of Brazil (“CVM”) Instruction 358, of January 3, 2002, as amended, hereby informs its shareholders and the market that it has been taking preventive and mitigating measures in line with the guidance established by health authorities to minimize as much as possible the impacts arising from the COVID-19 pandemic on people safety and on its business continuity.

Among the various measures adopted internally, which also are pertinent to public safety in general, are:

- Creation of an internal committee to discuss the matter;
- Adopting remote work for all employees who can perform their activities outside the company's facilities;
- Availability of hand sanitizers at all workstations, including in toll booths;
- Suspension of international travel and restriction on domestic travel;
- Frequent monitoring of potential operational, financial, and regulatory impacts on our business; and
- Regularly providing information and recommendations on the topic, and constantly monitoring for any changes and new guidance from officials in order to make any adaptation within our company.

As a result of the COVID-19 pandemic, the Company informs to the market its preliminary consolidated figures for the evolution in traffic for March 2020 and for the year 2020 to March 17, inclusive. The results presented are managerial and subject to revision.

Note: Equivalent paying vehicle is a basic unit of reference in toll collection statistics on the Brazilian market. Light vehicles, such as automobiles, correspond to an equivalent vehicle unit. Heavy vehicles such as trucks and buses are converted to equivalent vehicles by a multiplier applied to the number of axles per vehicle, as established in the terms of each concession agreement.

The Company reaffirms its commitment to its obligations as a publicly held corporation listed on the Novo Mercado segment of the B3 stock exchange, and will disclose all and any material information in accordance with the applicable legislation.
