## **Acquisition of Relevant Stake**

São Paulo, February 12<sup>th</sup>, 2020 – **Locaweb Serviços de Internet S.A.** ("**Company**") informs that, in accordance with article 12 of Instruction No. 358 of the Brazilian Securities Exchange Commission – Comissão de Valores Mobiliários ("**CVM**"), dated January 3, 2002, as amended, it received a letter from its shareholder GIC Private Limited ("**GIC**"), dated as of February 12<sup>th</sup>, 2020, in which it was stated that, by means of operations carried out in the trading session of the São Paulo Stock Exchange – B3 – Brasil, Bolsa Balcão, **GIC** becomes a shareholder that reached 5.32% of the Company's common shares, which totalizes the amount of 6,651,260 (six million six hundred fifty-one thousand two hundred sixty) shares.

**GIC** have also informed that the funds do not intend to change the control nor the administrative structure of the Company.
